Darren Allen, Esq.: An attorney in Randolph County, Darren Allen has tried hundreds of cases and dozens of jury trials on matters from impaired driving to first degree murder. He has also been involved as a coach for high school mock trial for eleven years and coaches the team that won state championship four of the last five years. Mr. Allen's teams have finished the season in the top 10 nationally on three different occasions.

Hailey Bunce, Esq.: Serving as an Assistant District Attorney in Pitt County, Ms. Bunce has extensive "real world" and mock trial experience. She graduated with honors from UNC Law School in 2015, where she served as President of the Broun National Trial Team and wrote for the *North Carolina Law Review*. Ms. Bunce participated in mock trial in both high school and college as a character witness and attorney. She has also mentored high school mock trial teams in both Orange and Pitt counties and served at our summer camp every year.

Philip Entzminger, Esq.: Serving as an Assistant District Attorney in Pitt County, Mr. Entzminger tries cases in Juvenile, District, and Superior Court. He shares his enthusiasm for the law as an adjunct professor at East Carolina University and Pitt Community College. For many years, Mr. Entzminger has also served as the Regional Coordinator for our Greenville mock trial competition and assisted with Teen Court in Pitt County.

Rick Glazier, Esq.: As the Executive Director of the North Carolina Justice Center, Mr. Glazier works to eliminate poverty and ensure economic security for every household in the state. Prior to joining the NCJC, Mr. Glazier represented Cumberland County in the N.C. House of Representatives, where he focused many of his efforts on strengthening the educational system in our state. He has been teaching at Campbell University School of Law for 22 years and is a perennial judge at our regional and state finals mock trial competitions.

Susan H. Johnson, M.P.H.: As the State Coordinator for the CCCE, Ms. Johnson oversees the statewide high school mock trial program. She was instrumental in NC's hosting of the 2015 NHSMT Championship in Raleigh. She also volunteers with the American Mock Trial Association. Prior to joining the CCCE, Ms. Johnson coached high school mock trial and moot court teams that earned honors at national and international competitions.

Mark Kleinschmidt, Esq.: Currently practicing criminal defense law after many years of capital defense work, Mr. Kleinschmidt served as the Mayor of Chapel Hill from 2009 - 2015. Prior to obtaining his J.D., he served as a high school teacher in Charlotte. In addition to joining us at summer camp, Mr. Kleinschmidt continues to invest in high school students by serving as a team attorney advisor.

Brooke Schmidly, Esq.: A JAG officer in the United States Air Force Reserve, Brooke Schmidly worked as an Air Force Judge Advocate General for 6 years before entering private practice in Asheboro, NC. Ms. Schmidly has extensive experience in civil litigation, personal injury, and criminal defense. A member of the CCCE Board of Directors, Ms. Schmidly also has served as a team advisor for a local high school.

Lisa Williams, Esq.: A graduate of UNC-Chapel Hill School of Law, Lisa Williams served as an Assistant District Attorney in Durham County for four years, prosecuting cases ranging from narcotics to attempted murder. Since 1998, Ms. Williams has crossed the aisle to work as a criminal defense attorney, primarily representing indigent clients. Ms. Williams has also assisted a charter school mock trial team in Durham.

Nicole Winget, Esq.: A Lieutenant in the United States Navy, Nicole Winget has deployed to Kuwait and Afghanistan and is currently with the Sixth Fleet, stationed out of Atlanta, GA. She attended Ohio Northern University College of Law, where she competed with and coached the trial advocacy and moot court teams. Ms. Winget is a Professor of Homeland Security and Criminal Justice at Campbell University. She also serves as a team advisor.
