

GIVE AND TAKE: THE SURPRISING SECRET TO SUCCESS

"It is more blessed to give than to receive." When you heard those words as a child, you may not have believed them. But with age often comes wisdom and the realization that the joy of surprising someone with the "perfect gift" surpasses even the delight of receiving such a gift. We've all experienced it, whether watching your child squeal in delight on Christmas morning, or watching your friend's face glow when your gift is revealed. Those who bless others, are blessed in return.



This principle, while in the forefront of our minds during the holidays, is true year-round in both our personal and professional lives. As Wharton professor Adam Grant convincingly demonstrates in his best-seller *Give and Take: A Revolutionary Approach to Success*, "Givers" are more likely to be successful than either "Takers" or "Matchers." This result surprises many, who would expect Matchers, or perhaps even ruthless Takers, to experience the greatest success. But the results of Grant's research were clear, and they held true regardless of whether individuals were introverts or extroverts, open-minded or traditional, conscientious or carefree.

Why is this so? Grant proposes that people work harder if they feel like they are helping others and making a difference. Such motivation inspires them to give

their best effort and not give up when difficulties arise, increasing their likelihood of success.

But Grant also notes that "Success involves more than just capitalizing on the strengths of giving: it also requires avoiding the pitfalls" (p. 155). Some givers end up exhausted and unproductive, while others are passionate and successful. What causes the difference? Why do some givers end up as doormats, while others become inspirational leaders?

According to Grant, successful givers are more other-oriented than their peers – and also more self-interested. They are, in his words, "otherish." They care about benefitting others and are willing to give more than they receive. Yet they use their own interests to guide them in choosing when, where, how, and to whom they give. They are positioned to excel, help others, and succeed themselves.

Often, individuals enter the legal profession because it offers a chance to defend the defenseless, help heal the injured, and bring about justice—all of which are rewarding to both the client and the attorney.

And many attorneys don't stop there; they generously invest in our N.C. youth by serving as **attorney advisors** to high school mock trial teams. Those who do so, find that they receive more than they give. As one team mentor remarked, "Coaching mock trial has been the most rewarding experience of my professional career. I do not think there is any other extracurricular activity that better develops critical thinking skills or hones public speaking than mock trial."

We still need advisors for teams in Union County and Winston-Salem. Many other legal professionals "pay it forward" by serving as jurors and judges at our **Regional competitions**, which will take place across the state on **Saturday**, **February 7**, **2015**. Each regional site will need 40 – 50 local legal professionals to serve as presiding judges and scoring jurors, as well as a dozen or more site volunteers behind the scenes.
