

## NORTH CAROLINA ADVOCATES FOR JUSTICE HIGH SCHOOL MOCK TRIAL COMPETITION

## **Easy Steps to Starting a Mock Trial Team**

- 1. If you are part of a school, talk with your high school's principal and find out if there is a teacher who can serve as the team's advisor. Each team *must* have an adult advisor. A team consists of 7-9 students. There is no limit on the number of teams which a school or organization can sponsor.
  - For an independent organization (Teen Court, homeschool support group, YMCA, etc.), all students must be active members of the sponsoring organization.
- 2. Ask the team advisor to register your team(s). Please fill out and submit the Registration form by the deadline. All necessary forms and important information are available on our site <a href="http://ncmocktrial.org/">http://ncmocktrial.org/</a> under the heading "Competitions" → "Important forms."
- **3.** Contact a local attorney to invite them to volunteer as your team's legal advisor. If you need help, contact Executive Director Liz Avery-Jones at <a href="liz@ncmocktrial.org">liz@ncmocktrial.org</a> and we will match you up with an attorney advisor in your area. We recommend that an attorney advisor meet with their team for a minimum of five to six times of 2-3 hours each to prepare the team for competition (this will vary depending upon the attorney's availability).
- **4.** Study all of the official case materials (available on the website), including the Rules of Competition and the NCHSMT Rules of Evidence and Procedure.
- **5.** Select and assign your team roles. There are 14 roles to assign: 3 Prosecution/Plaintiff attorneys; 3 Defense attorneys; 3 Prosecution/Plaintiff witnesses; 3 Defense witnesses; 1 Bailiff/timekeeper (on Prosecution/Plaintiff side), and one Timekeeper (on Defense). Thus, some team members will have to assume two roles.
- **6.** Schedule practices and rehearsals to prepare for competition. The NCMTP also offers to pair each team with another team for online scrimmaging (and will ensure your team doesn't see that team at competition). As you prepare for competition, remember that no outside research is necessary since you are limited to the case materials. It is highly recommended that attorney advisors arrange at least one practice in a courthouse if possible, to familiarize students with the courtroom setting.
