### The Defendant Donna O'Grady

We hope all students saw our <u>second 2021-22 case clarification</u>. At trial, the Fifth Amendment gives the criminally accused the right not to testify. This means that the prosecutor, the judge, and even the accused's own lawyer cannot force the accused to take the witness stand against their will. In <u>State of Utopia v. O'Grady</u>, Donna O'Grady is exercising her **Fifth Amendment** right not to testify. However, the **Sixth Amendment** provides that a person accused of a crime has the right to confront a witness against him or her in a criminal action. This includes the right to be present at the trial.

It's rare to have a high school mock trial case where the defendant is not a witness! In light of the unique circumstances of this mock trial case, teams ARE ALLOWED to have an official team member sit at counsel table during trial to pose as the accused (optional) (a non-speaking/non-testifying/non-scored role). Additionally, for purposes of the competition, no team is permitted to comment in argument or testimony on the absence or presence of the accused at trial.

**Post script**: A third case clarification has been posted to correct a point of U.S. history: The U.S. military did not have a presence in Afghanistan when Dan O'Grady and Cameron Kravitz were in the Army; therefore, line 37 of Kravitz's affidavit has been adjusted to read "the Middle East".

# Fall/winter scrimmage practice
