COMPETITION CASE PUBLISHED ON SEPTEMBER 6

The North Carolina Mock Trial Program is planning to hold the 2023 Regional Mock Trial Competition (including our courtroom artist competition) in-person throughout the state on **Saturday, February 4, 2023**. The competition Rules book, now published <u>online</u>, retains the 2022 rules regarding virtual competitions in the event that we must go virtual. Regardless, we are planning for and very much looking forward to seeing everyone live in 2023! And here is a <u>Memo</u> regarding some big Rule changes for 2023.

Students participating in the 2022-2023 NCAJ High School Mock Trial Competition will be presenting both sides of a Civil Defamation case, *Morgan Matthews vs. Utopia Resort and Spa*.

Defamation in and of itself is a statement or statements that injures a third party's reputation. Morgan Matthews, an impassioned news reporter who may be a little inclined towards embellishing the facts, finds him/herself in the middle of an exposé after he/she is exposed to bed bugs in the luxurious Utopia Resort and Spa. Matthews believes "the people who condemn me are often the people whom I have targeted."
