

2025 – 2026 Competition Schedule

September 5, 2025 – Registration Opens

Register your teams, including courtroom artists, early at https://ncmocktrial.org/compete to have a better chance of securing your first choice of site assignments. If your school has multiple teams, and you do not want them to compete against each other at Regionals, select different site preferences for each team.

September 5, 2025 – Case Release Date

October 31, 2025 – Final Registration Deadline

October 31, 2025 – Final Registration Fee Deadline

December 19, 2025 – Withdrawal Deadline

If your team must withdraw from the competition, contact the Program Administrator in writing, at admin@ncmocktrial.org, no later than December 19, to receive a full refund of registration fees. Requests to withdraw received after that deadline will result in forfeiture of fees and possible additional penalties (See Competition Rule 1.8), due to the significant disruption caused by late withdrawals.

February 7, 2026 – Regional Competitions

Mock trial teams and courtroom artists compete at regional sites throughout North Carolina including Fayetteville, Gastonia, Goldsboro, Greenville, Hendersonville, Hickory, High Point, Hillsborough, Lincolnton, Raleigh Campbell, Raleigh Courthouse, and Wilmington. All materials and program information can be found at https://ncmocktrial.org/compete. (Teams will be responsible for bringing Bailiff/Timekeeping Sheets and Dispute Forms to the competition.)

Teams at all sites will compete in two rounds of competition and will try both sides of the case. The top two teams will compete in a final round, with the winner advancing to State Finals. Regional courtroom artist winners will be invited to compete at State Finals.

On Friday, March 13, all teams will arrive in Raleigh for registration, Round I, and the Widenhouse/Britton Award reception.

On Saturday, March 14, all teams will participate in two rounds of competition. The two topranking teams will then compete in a final round. The State Champion will earn the right to represent North Carolina at the **National High School Mock Trial Championship** Competition in Des Moines, Iowa from May 7 - 9, 2026.
